## NOTICE TO EMPLOYEES IN CASE OF WORK-RELATED INJURIES

- In New Jersey, the workers' compensation law provides wage loss and Medical benefits to employees who cannot work, or who need medical care, because of a work-related injury.
- 2. Benefits are required to be paid by your employer when self-insured, or through insurance provided by your employer. Your employer is required to post the name of the company responsible for paying workers' compensation benefits at its primary place of business and at its sites of employment in a prominent and easily accessible place.
- You should report immediately any injury or work-illness to your employer. Your benefits could be delayed or denied if you do not notify your employer immediately.
- 4. You have the right to seek emergency medical treatment from any provider of your choosing, but you have an obligation to advise Synergy Comp Insurance of this care as quickly as possible. Any subsequent non-emergency treatment for a work related injury or illness will be at the direction of Synergy Comp Insurance. You must select a provider from the below list <u>before</u> seeking medical care for all non-emergency, work-related injuries and illnesses.
- 5. You have the right to seek medical care for a work related injury or illness without obtaining proper authorization, but understand that Synergy Comp Insurance and your employer are <u>not</u> responsible to pay for this treatment.
