The Zero Suicide Framework is comprised of seven elements representing a holistic approach to suicide prevention and care within behavioral health care systems. We believe this approach improves the care and safety of those we serve and our staff, thereby making our organization a safer, and, hopefully, more fulfilling place to work.

The Zero Suicide Committee works to support the full implementation and continuous quality improvement and fidelity to the Zero Suicide model. We are committed to leading a system-wide culture committed to reducing suicides through education, policy changes, and an organized coordination of care. As members of the Zero Suicide Committee, we continuously assess the needs of Center For Family Services, create ongoing agency wide strategic plans on suicide prevention and care to address identified needs, and implement core activities to reach our goals.

Our Vision:
